Mr. Edkin moved to approve the update of the Health & Safety Plan number of positive building cases from 3 cases to 4 cases to determine a school closure and update the number of closure days to 3 to 5 days. Mr. Hill seconded the motion and it passed with the following votes: Yes votes: Mr. Earnest, Mr. Edkin, Mr. Hill, Mr. Johnson, Mr. Walker No votes: Mrs. Auten, Mr. Frederick, Ms. Sleboda, Mrs. Woodward

Mrs. Woodward moved to approve amending the High School Calendar to convert the following dates to Distance Learning Days: 12/21/20, 12/22/20, 1/4/21, 1/5/21, 1/6/21, 1/7/21, 1/8/21. Mr. Walker seconded the motion and it passed with eight yes votes and one no vote from Mr. Earnest.

Mr. Edkin moved to approve enacting exception to allow student athletes not to wear masks while participating in athletic events including weight room activities unless masks are required for competition or the trainer recommends wearing mask during practices leading up to competition where mask will be required. Mr. Hill seconded the motion and the motion failed with the following votes: Yes votes: Mr. Edkin, Mr. Hill, Mr. Johnson

No votes: Mrs. Auten, Mr. Earnest, Mr. Frederick, Ms. Sleboda, Mr. Walker, Mrs. Woodward
