

Muncy School District
Board of Education
Reorganization Meeting
December 4, 2017

The Muncy School District Board of Directors held their annual reorganization meeting at 7:00 p.m. in the Muncy Junior/Senior High School Library, 200 West Penn St., Muncy, PA, 17756.

Present were: Connie Coyner, Ty Fry, Scott McLean, Rhondel Moyle, Justin Reis, Lisa Sleboda, Robert Titman, Kim Walker and Sarah Woodward.

Members of the administration present were: Superintendent Craig Skaluba, Business Administrator David Edkin, and Assistant to the Superintendent for Curriculum and Instruction Kimberly Hamilton.
