Mr. Johnson gave a report to the board regarding BLaST IU #17 – Upcoming meeting on 9/18/24

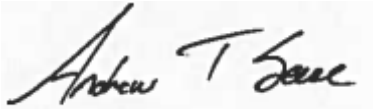
